# NOTICE TO VENDORS INSTRUCTIONS FOR CONFLICT OF INTEREST QUESTIONNAIRE FORM

H.B. 914, requires a vendor that wishes to conduct business or be considered for business with City of Heath to file a "conflict of interest questionnaire." The Texas Ethics Commission (TEC) created the conflict of interest questionnaire (FORM CIQ).

Section 176.006 requires disclosure of a person's "affiliations or business relationships that might cause a conflict of interest." The term "affiliation" is not defined in Chap. 176. However, the general definition of the word "affiliation" would mean any association or connection. So any affiliation, including such things as friendship, membership in some group or organization, residence in the same neighborhood, relationship by blood or marriage, or any other connection, must be disclosed.

## How to fill out the Conflict of Interest Questionnaire form:

- 1. Fill in the full name of the person or company who is trying to do business with the City of Heath. If the business is a corporation, partnership, LLC, LP, etc., then each person who acts as an agent for the business in dealings with City of Heath must complete this form.
- 2. Check box if the form is an update to a form previously completed.
- 3. Enter name of the City of Heath Council Member, Departmental Head or City Manager about whom the information is being disclosed.

If no affiliation or business relationship exists, state "none."

4. Describe how you are affiliated or related to the City of Heath Council Member,
Department Head, or City Manager or affiliated or related to a family member a
Department Head, Council Member or City Manager as described by Section 176.003(a)
(2)(A).

Also describe any family relationship with a board member or officer.

## If no affiliation or business relationship exists, state "none."

- Section A. If a board member or officer or any of their family members receiving taxable income, other than investment income. Check "No" if this doesn't apply or affiliation is "none"
- Section B. Is the vendor receiving or likely to receive taxable income, other than investment income, from a board member or officer or any of their family members and the taxable income not received from City of Heath. Check "No" if this doesn't apply or affiliation is "none".
- 5. Describe the business relationship that exists. If there is no affiliation, state "none".
- 6. Check this box if the vendor has given a board member or officer or any of their family members one or more gifts as described in Section 176.003(a)(2)(B).

## CONFLICT OF INTEREST QUESTIONNAIRE For vendor doing business with local governmental entity

A complete copy of Chapter 176 of the Local Government Code may be found at http://www.statutes.legis.state.tx.us/Docs/LG/htm/LG.176.htm. For easy reference, below are some of the sections cited on this form.

<u>Local Government Code § 176.001(1-a)</u>: "Business relationship" means a connection between two or more parties based on commercial activity of one of the parties. The term does not include a connection based on:

- (A) a transaction that is subject to rate or fee regulation by a federal, state, or local governmental entity or an agency of a federal, state, or local governmental entity;
- (B) a transaction conducted at a price and subject to terms available to the public; or
- (C) a purchase or lease of goods or services from a person that is chartered by a state or federal agency and that is subject to regular examination by, and reporting to, that agency.

## Local Government Code § 176.003(a)(2)(A) and (B):

- (a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:
  - (2) the vendor:
    - (A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, other than investment income, that exceeds \$2,500 during the 12-month period preceding the date that the officer becomes aware that
      - (i) a contract between the local governmental entity and vendor has been executed; or
      - (ii) the local governmental entity is considering entering into a contract with the vendor;
    - (B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:
      - (i) a contract between the local governmental entity and vendor has been executed; or
      - (ii) the local governmental entity is considering entering into a contract with the vendor.

#### Local Government Code § 176.006(a) and (a-1)

- (a) A vendor shall file a completed conflict of interest questionnaire if the vendor has a business relationship with a local governmental entity and:
  - (1) has an employment or other business relationship with a local government officer of that local governmental entity, or a family member of the officer, described by Section 176.003(a)(2)(A);
  - (2) has given a local government officer of that local governmental entity, or a family member of the officer, one or more gifts with the aggregate value specified by Section 176.003(a)(2)(B), excluding any gift described by Section 176.003(a-1); or
  - (3) has a family relationship with a local government officer of that local governmental entity.
- (a-1) The completed conflict of interest questionnaire must be filed with the appropriate records administrator not later than the seventh business day after the later of:
  - (1) the date that the vendor:
    - (A) begins discussions or negotiations to enter into a contract with the local governmental entity; or
    - (B) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential contract with the local governmental entity; or
  - (2) the date the vendor becomes aware:
    - (A) of an employment or other business relationship with a local government officer, or a family member of the officer, described by Subsection (a);
    - (B) that the vendor has given one or more gifts described by Subsection (a); or
    - (C) of a family relationship with a local government officer.
